### Familiarisation Programme for Independent Directors

### **Induction Programme for New Independent Directors**

- At the time of induction, presentations are made to the new Independent Director, which include information about the Company's Profile, Business Model, Organisational structure, the Company's history and milestones and Talent and Leadership overview.
- An appointment letter outlining the roles, responsibilities, duties, remuneration, performance evaluation process, insurance cover, Code of Conduct and obligations on disclosures is issued to the new Independent Director

### **Ongoing Familiarisation Programme to update Directors**

- Plant visits are arranged for Independent Directors, wherein plant head apprise them of the operations, quality, safety, sustainability, etc.
- Presentations are made at the Board and Board Committee Meetings, on Business and performance updates of the Company, business strategy and risks involved, financials, working capital management.
- Directors are periodically updated on major developments in legal & regulatory areas, like Companies
   Act, Listing Agreement, and various Tax and financial reporting changes.
- Business and functional reviews are arranged for on a periodic basis with the respective leaders by rotation.
